



Center Grove Wrestling Club

Meeting Minutes

November 10, 2009



Call to Order

Keith Adams called to order the regular Center Grove Wrestling Club board meeting on November 10, 2009 at Center Grove High School.

Roll Call

Those present were Cale Hoover, Keith Adams, Jeff Johnson, Ed Lyons, Neil Segó, Cindy thrasher, Karen Carmichael, Renee Schoettle, and Derrick Thomas.

Minutes from the October 13, 2009 board meeting were approved with no objections and Neil Segó will post them to the website.

Business

1. Financial Update

- a. Keith Adams handed out a current profit and loss statement and budget comparison through November 9, 2009. The budget comparison shows we are on track with financial goals set.
- b. All bills to date are in with the exception of the t-shirt bill.
- c. High School needs have been met, however we do need to purchase frames for charters, pictures, awards, etc.
- d. There have been two Applebee's nights this fall, but we have not seen any money from them at this point. Renee will follow up. Both nights appear to have gone well and the next Applebee's night is scheduled for December 2, 2009. The club and camp brought in \$3,470 of our goal set at \$3,500. We currently have raised \$1,080 for the Trojan Wrestler and are working toward a goal of \$2,500. Evergreen agreed to sponsor us, but we have not received their money. Jeff Johnson will follow up with them.

2. Spiritwear / Supplies

- a. Parents of High School wrestlers are handling spirit wear orders. The order form will be posted on the website and be made available to elementary and middle school parents.
- b. Coach Hoover will place the order for 300 water bottles (cost \$425). Each wrestler will receive one bottle, including high school wrestlers. If a wrestler needs to replace a bottle, it will cost \$2. Water bottles will be held for future wrestlers and not sold a meets.
- c. Coach Hoover wants to clean out closet and sell all old warm ups.

3. Club and Camp Items

- a. The club was honored as a gold member by USA Wrestling. The club is one in six receiving this honor nationally. Criteria for gold honorarium is raising membership, competing in all three wrestling styles, having a bronze certified coach, and participating in national events.
- b. Ed Lyons suggested a movie night to raise additional funds for the club. Parents will have to purchase tickets in advance for children to enjoy a movie, games, and pizza. A tentative date and time of

December 12, 2009 from 5 PM - 8:30 PM has been set. Coach Hoover will seek facility approval and a projector. Cindy Thrasher stated that her sister could work on the details and flier for the event.

- c. We had 88 wrestlers for the camp, up 18 children from last year. We reached our goal of \$4,000.
- d. We have 29 wrestlers confirmed for the elementary dual team. The parents must have the money in for the dual team prior to the first meet on November 22 in or to compete on the team. Neil Segó will have a wrestle off for the team. Other wrestlers will get exhibition matches.
- e. We are currently booked for four dual meets and will stay with that number this year. The goal is to expand on this next year. There will be no discount given to wrestlers who cannot participate in all dual meets. Only one exception was noted with relation to age of wrestler and limitations of that particular dual.
- f. The club will hand out singlets the morning of the dual meets and collect them after the meet. The club will also take care of laundering them. Club singlets will be given to kids competing in exhibition matches and handled in the same way as the dual team singlets.

4. Other / Coach Hoover Discussion

- a. A work date needs to be set to build some shelves and organize the closet. Approximately eight totes will need to be purchased to keep materials organized.
- b. The next meeting date was scheduled for December 15 at 6 PM.

Since this meeting the next meeting was re-scheduled for Wednesday December 16 at 6 PM due to a change of date for a High School meet.
